

## **Biography of Dr. Wang Zhenyu**



Dr. Wang Zhenyu is currently head of research section of China National Committee for Pacific Economic Cooperation (CNCPEC).

From July 2017 to July 2023, Dr. Wang was posted in the Chinese Embassy in Wellington as First Secretary.

From August 2006 to July 2017, Dr Wang was working with CNCPEC and was promoted to be Associate Research Fellow academically in 2012, and administratively, Deputy Director in 2011 and Director in 2013 of the Secretariat of CNCPEC.

From 2010 to 2015, Dr Wang pursued his doctorate studies on economic cooperation in the Asia Pacific region in the Graduate School of China Academy of Social Sciences.

From Jan 2004 to August 2006, Dr. Wang was posted in the Chinese Embassy in Port Moresby as Third and then the Second Secretary and head of political section.

In 1998, he joined CNCPEC after graduating from the English Department of Peking University with a MA in English Linguistics.

Dr Wang graduated from Peking University with a MA in English Linguistics in 1998 and East China Normal University as an English Major with a BA in English Language and Literature in 1991. He taught English in Nanjing Institute of Meteorology from 1991 to 1995.

Dr Wang has been involved in a series of intellectual undertakings, including the various seminars on regional economic integration organized by CNCPEC.

Dr. Wang undertook to compile the book of “New Directions in Asia-Pacific Economic Integration”, edited by Amb Tang Guoqiang and Peter A. Petri, published by East West Center in

2014, based on a international workshop in 2013.

Dr. Wang was involved in organizing the APEC ISOM Symposium in December 2013 and the PECC General Meeting 2014. Dr. Wang was a member of the work team on the next generation trade and investment issues, which was responsible for drafting the relevant side documents of APEC 2014 meetings. Dr. Wang's contribution was recognized by the relevant ministries.

Dr. Wang also drafted the Executive Summary of Symposium "FTAAP: Asia Pacific Economic Cooperation by 2020 and Beyond" as recommendations for FTAAP Collective Strategic Study in 2015 and the Executive Summary of international Symposium on "Connecting the Connectivities in Asia-Pacific" in 2016. The latter was accepted by the APEC CSOM 2016 (2016/CSOM/017 Agenda Item: 3.2).

Dr. Wang was also closely engaged in introducing and promoting the work done by APEC by way of writing op-eds and accepting interviews.
